## **CCA ADMISSIONS**

Coastal Christian Academy exists to help prepare children to be disciples of Jesus Christ. #### **CCA STATEMENT OF FAITH**

Ultimately, CCA belongs to God and it is our commitment to do His will in all circumstances.
